






Comic Book Eras

- Golden Age (1938–1956) Superman, Batman, Wonder Woman, Mickey Mouse, Tarzan, Roy Rogers, Strange Tales, Little Lulu, Captain America
- Silver Age (1956-1970) Fantastic Four, Spider-Man, X-Men, Hulk, Casper the Friendly Ghost, Classics
 Illustrated, Thor, Daredevil, The Avengers
- Bronze Age (1970–1986) House of Secrets (Swamp Thing), The Tomb of Dracula, Luke Cage, Howard the Duck, Punisher, Wolverine, Blade, Vampirella



Marvel's Silver Age Dynamic Duo: Jack Kirby and Stan Lee


Artist Jack Kirby and writer Stan Lee were responsible for some of the most collectible comics ever produced including the Fantastic Four, Hulk, and the X-Men.

What is in demand and what isn't

- ▶ 1. Scarcity: How many were produced and how many are available?
- ▶ 2. Popularity: Evergreen appeal doesn't necessarily translate to value
- > 3. Trending: Are people talking about it on social media?
- 4. Social Change: Is it still acceptable to collectors?

▶ 5. Size matters: How easy is it to display and store?

Asking Price vs. Sales Price








Practical Considerations
