We survived the transition to online courses with a full academic year online. This next year will be another year of transitions. We will go from full online this fall, to a winter mini semester that will see an experiment in hybrid – that is, inperson and online at the same time – courses, then, we hope, full in-person courses back at Locust Grove this coming spring. This just proves how flexible we are.


