• Loneliness Discussion - Robin Torres

- (3) N. Yurasko discussed that he might see a poster for an event or something on the TV. He believes there should be a direct connection of a "set calendar" to have one location to identify events

- (5) The majority of the assembly agrees that there is an issue with loneliness on campus.
